# Joint Board Meeting of LWCHA/IPHCA/LWCCOA March 29, 2024

Call to Order and Establish Quorum

Present: Paul Banas, John Davisson, Ronda Hipshman, Greg Steinke, Les Blumenthal, John Penrod, Scott Whitmire, Judy Sims, Don Olson (Zoom), Mike Ramos, Linda Salazar and Dena Patterson

- II. Reserve Funding—John Penrod
  - A. Review of Reserve statutes and the funding relationship between LWC and IPHCA
    - 1. Assets covered by reserve are all owned by LWC; there is no fractional ownership
    - 2. Reserves cannot be transferred to another organization as they are now to IPHCA
    - 3. Reserves cannot be transferred to Operations, but can be borrowed and repaid
    - 4. RDH prepares/updates Reserve study based on same criteria for all LWC assets (LWCHA IPHCA, LWCCOA), which is used for input to the budget plan
  - B. Review of separation of IPHCA and LWCHA Reserves
    - 1. IPHCA funding on own will raise IPHCA HOA fees by about \$25 per month
    - 2. IPHCA funding will reduce LWC HOA fees by about \$4 per month
  - C. Recommendation
    - 1. Stop the current funding process
    - 2. Return all funds already transferred back to LWCHA
    - 3. Have one Reserve fund for entire community, administered by one LWCHA Reserve Committee to include membership from IPHCA and LWCCOA
  - D. Discussion
    - 1. Steinke recommended going back to original MOU based on Oregon Statutes
    - 2. Salazar indicated IPHCA may get an attorney to study this issue
    - 3. Further discussion on MOU. Paul Banas gave Linda Salazar the required written 30day notice from LWCHA to IPHCA to terminate the current (2022) MOU.
- III. Innisfree voting member on Architectural Committee

Paul Banas explained that the AC allows all six members to vote on all AC project applications, and until recently had two IPHCA members on the committee. He also stated that current By Laws indicate three regular members and three alternates, but would work with the ad hoc Governance committee to formally recognize six regular members on the AC in proposed revisions to the Governing documents.

  - B. Plan includes fence, trees and berm
