LWC Safety Committee's Webpage

The LWC Safety Committee's mission is to help residents help themselves to prepare for and manage emergency situations.

In the event of a major emergency, it is likely that we will be stranded in LWC and that outside assistance will not be able to reach us for 2-6 weeks!

While this is certainly a daunting prospect, there are steps we can all take to make the situation more manageable. Since it was formed twenty years ago, the LWC Safety Committee and its Safety Captains have developed resources and conducted educational programs to help our residents prepare to be self-reliant in various emergency situations.

Safety Captains are LWC residents who volunteer to help their neighbors prepare in advance for emergencies. During an emergency situation they will shelter in place with their own families, and are not expected to leave the safety of their home to assist anyone unless they choose to do so. Please review the inventory of our Safety Operations Center (SOC) to understand that each household needs to be prepared with their own water and food.

Your household can be 2-6 weeks ready for a major emergency by doing the following

I. Prepare in Advance

- Prepare a go-bag in case we are instructed to evacuate
- Make a personal plan to manage a 2-6 week period of physical and social isolation
- Know what Safety Area you live in and who your Safety Captain is
- Buy and learn to use a two-way radio and keep it charged
- Sign up for alerts of local emergencies
- Check our webpage for local, state and federal resources
- Stock resources for 2-6 weeks: water, food, hygiene, first aid, sanitation
- Team up with friends and neighbors to normalize safety preparedness and discuss options to help each other

- Develop a list for renters, visitors, etc. to help them if you are not there during an emergency
- Talk with your Safety Captain if you need assistance, or email <abradley342@yahoo.com> with questions

II. During an Emergency

- Call 911 for a personal emergency
- Check LWC Community Radio Service (CRS) on channel 15 at the top of the hour during a community-wide emergency
- Shelter in place unless directed to evacuate

Tips for preparing for an emergency situation

- Electric garage doors will not operate- know how to open yours manually
- Roads may be closed or jammed with traffic. We may be isolated
- ATM's may not operate or may not have cash Keep cash on hand
- Gas stations may not be operational, or may not have gas. Keep your gas tank 1/2 full, have fuel for generator, lighting, cooking and heating options.

Prepare to shelter in place

- Plan to shelter in place in your own home, or to shelter with a friend or neighbor if the safety of your home is compromised
- Consider sharing your resources with someone who may need assistance
- Review the inventory of our Safety Operations Center (SOC) to understand that each household needs to be prepared with their own water and food. The (10) 55 gallon barrels of potable water that are stored in the Rec Center would last approximately three days, and we have less than one day's supply of non-perishable food, depending on the number of residents present.
- Review EP Items and Tools on our webpage for recommendations of items you may want to include in your personal household EP cache

- Review the inventory of a LWC homeowner's personal EP Cache
